Warrantor will, at its option, replace or refund, subject to the prorated schedules set forth below, the purchase price of any Product that exhibits a manufacturing defect resulting in splintering, rotting, termite damage, or fungal decay occurring under normal use in standard commercial or multi-family applications during the applicable warranty period set forth below.

#### **TRANSFERABILITY**

This warranty is freely transferrable. Any current owner of the Products can make a claim under this warranty. The warranty period will run from the date of the initial sale of the Products.

#### WARRANTY DURATION

The Products carry a 10-year limited warranty when used in standard commercial or multi-family applications, subject to all of the terms and limitations set forth herein. The products will be replaced or refunded according to the following prorated schedule:

(United States and Canada Only)

UFP Warranty Corp ("Warrantor") is pleased to offer this Warranty to the owner of capped wood plastic composite or Eovations® technology decking products manufactured by Universal Consumer Products, Inc. ("Product(s)").

#### STAIN RESISTANCE

Warrantor will, at its option, either replace or refund the appropriate prorated portion of the purchase price as set forth in the "Prorated Refund Schedule" below for any Product used in a standard commercial or multi-family decking or railing application that exhibits permanent staining in the first 10 years from the date of purchase when exposed to food and beverage spills, including wine, tea, coffee, fruit punch, sodas, catsup, salad oils, barbeque sauces, mustard and other food- or beverage- related items that would typically be present on a deck. This Warranty will only apply if an attempt is made by owner to remove any such spill from the decking material with water and mild household cleaners within forty-eight (48) hours of exposure to the surface, and such attempt is unsuccessful.

#### **FADE RESISTANCE**

Warrantor will, at its option, either replace or refund the appropriate prorated portion of the purchase price as set forth in the "Prorated Refund Schedule" below for any Product used in a standard commercial or multi-family decking or railing application that exhibits "Excessive Color Fade" within the first 10 years from the date of purchase. Excessive Color Fade is defined as a change in color greater than five (5) Delta E (CIE) when calculated according to ASTM D2244 for all non-variegated color surfaces. Excessive Color Fade for variegated color surfaces is defined as an unreasonable amount of color change in excess of "Normal Weathering."

This warranty is freely transferrable. Any current owner of the Products can make a claim under this warranty. The warranty period will run from the date of the initial sale of the Products.

Stain Limitations: The Products are not stain-proof. Care must be taken to remove all food, beverage and other spilled materials with water and a mild household cleaner within forty-eight (48) hours of exposure. Stains resulting from spilled abrasive compounds of acidic or basic pH, strong solvents, oil-based paints or stains, metallic rust and other abnormal items not commonly used on a deck are excluded from coverage under this Warranty; Excluded stains include but are not limited to pet or human bodily fluids such as blood, vomit, urine or feces, and fungicides, bactericides, biocides and chemical-based plant food. Mold and mildew can settle and grow on any outdoor surface and, if not properly cleaned, can stain that surface. Staining associated with mold or mildew is not covered under this Warranty. If stains persist, you will be required to produce documentation that you attempted to have the deck professionally cleaned at least one time prior to making a claim under this Warranty.

Fade Limitations: No decking material is fade-proof when exposed to sunlight and other common atmospheric conditions. Normal Weathering is to be expected over the life of the Product and is not covered under this Warranty. Normal Weathering is defined as exposure to sunlight and extremes of weather and atmosphere that will cause any colored surface to gradually fade, chalk, or accumulate dirt or stains.
